House Budget Subcommittees Recommend Cuts

The House budget subcommittees are completing their work this week. Recommendations for funding levels of state services and programs will then go to the full House Finance Committee for consideration. Each budget subcommittee chair was given an allocation (or a cap) to meet. For most departments the cap meant the subcommittee had to identify reductions within the department from last year's funding level. If you recall from news earlier this year, the legislative majorities decided to ignore Governor Knowles' operating budget requests which included additional funding for education and investments in child-related programs, including health services, child care, and youth detention.

On Saturday, March 4, the House Finance Committee has scheduled a **state-wide teleconferenced public hearing** on the budget. The time allotted for rural Alaska, including the rural LIO's, is 11:00 - 1:00. While there are some obvious areas of concern to rural Alaska in terms of recommended levels of cuts to specific programs, I encourage you to take the opportunity to testify in support of any state-funded program that you consider valuable in your community. For example, no decision has yet been made about the level of **Municipal Assistance and Revenue Sharing**. The full Finance Committee will be addressing that issue. We have no long term funding source for **PCE**. You may wish to comment on **public broadcasting**, **domestic violence or VPSO** funding--or funding for your **schools**. The important thing is, this is an opportunity to share concerns from our area.

Next week the House Finance Committee will consider amendments to the subcommittee's recommendations. If you did not testify at the March 4 meeting, you can still voice your opinion by contacting House Finance Committee members. The majority is looking for \$30 million in cuts, so our message concerning programs that are important to us are important.
