1. The University President, Board of Regents, and the Governor have requested a \$16.9 million increase for the University of Alaska. Do you favor this request? Why or why not?
2. With a slight downtrend in enrollment statewide, the school funding formula calls for a \$19.1 million reduction in the K-12 education budget. Do you approve of this loss of fund? What should the legislature do about it?
3. The Governor's budget proposed this year has been called "the Children's Budget" because it addresses a wide variety of children's issues from child abuse and neglect, foster care, childcare assistance, Head Start, and Healthy Families through Quality Schools and the University. Do you support these programs specifically and prevention measures in general?
4. Last September the Legislature asked the voters if they supported using a portion of the earnings of the Permanent Fund to help balance the state budget. The vote was 84% NO! What do you think NO meant? What is your recommendation as to how the Legislature should close the approximate 3/4 of a billion dollar shortfall in our budget?
5. The state budget encompasses many services including management of our resources, public safety, transportation, economic development, education, courts, environmental and health protection, public health and welfare, workforce safety and development. Overall do you think state services are adequate, too much, or too few. What would you strengthen or reduce?
