LEGISLATIVE REPORT — SUMMER 2000

Dear Neighbor,

hurchill once said that democracy is the worst form of government – except for all the others. This legislative session bore out that observation. After the usual mix of squandered opportunities, triumphs, and noisy chicanery, this legislature managed to leave the state relatively unscathed. Clearly, Alaska deserves more from the legislature than it leave Juneau without inflicting any harm on the state. It is time to raise expectations.

Inaction on Issues

The three issues that defined 1999 barely received consideration in 2000.

In spite of the efforts of several legislators, attempts to craft a long range fiscal plan for the state foundered in the wake of both the Permanent Fund vote and the current spike in oil prices.


In late September of last year, the House of Representatives tried to put a subsistence amendment on the ballot, but a group of eight Republican Senators prevented that initiative from reaching voters and, as a result, the federal government took control of Alaska's fish and game management on October 1.

Finally, the BP-ARCO merger became the BP-Phillips deal without any meaningful participation from the legislature.

Some Progress

Triumphs came primarily in three areas. First, the University received the additional support needed to make it a more vital part of Alaska's educational and economic landscape.

Second, the legislature ratified and funded the employee contracts, which will keep the state

open and ready for business this year.

Third, Power Cost Equalization (PCE) received long-term funding, which should encourage economic development in areas of the state that suffer from power costs up to six times of those in Anchorage.

Other Issues

Finally, there was a great deal of squawking as the majority put forward a

constitutional amendment to limit the ability of the public to offer initiatives relating to wildlife management. Although the reason for that bit of legislation was "the impact of Outside money" on Alaskan elections, efforts to create meaningful campaign reform went nowhere. In a further bit of irony, the same majority that opted to permit same-day aerial hunting rejected same-day voter registration.

What's Next


I draw a lesson from this session. In order to solve the state's problems, we must move past simple slogans and into substantive debate. We need now to figure a vision for the state, one that focuses more on what we want Alaska to look like in the future. I encourage all Alaskans to participate in the decisions on how to spend wisely – what investments are necessary for education, for infrastructure, and for public safety and how to secure the revenues to do Every perspective is important and every voice counts so, as we enter the campaign season, I encourage everyone to engage in political debate based on reason and civility.

Rep. Berkowitz's Bills 2000

Some legislation I sponsored and co-sponsored last session

- <u>HB 9 Filing of Settlement Information.</u> Allows collection of settlement information in civil litigation cases to assess the costs and benefits of tort reform (passed).
- <u>HB 29 Contraceptive Coverage.</u> Broadens the range of contraceptive options available to Alaskan families through their insurance plans (did not pass).
- <u>HB 31 UAA Consortium Library.</u> Provides funding for the new UAA library (funded as part of this year's bond package).
- <u>HB 215</u> <u>Renters Rebate for Seniors and Disabled Veterans.</u> Seeks to reinstate a program similar to the Property Tax Exemption for senior renters (did not pass).
- <u>HB 346 Services for Disabled Persons.</u> Provides more useful information about the availability of resources for disabled persons on waiting lists (passed).
- <u>HB 372 Community Based Sentencing.</u> Promotes Restorative Justice, which stresses accountability for the offender, restitution for the victim, and reconciliation for the community (passed).
- <u>HB 396 Student Loan Corporation; Municipal Bond Bank; AHFC.</u> Consolidates financial functions performed by the state (did not pass but I will try again!).
- <u>SJR 18 Exxon Valdez Damage Claims.</u> Encourages ExxonMobil to pay the jury award stemming from the Exxon Valdez oil spill (passed).
